## Newly Founded Research Programs

#### Governance of Natural Resources

—DEAN LUECK, PROGRAM DIRECTOR

The Program on Governance of Natural Resources was created in 2016 to develop a network of scholars to examine the institutions that govern natural resources. The program supports and disseminates



the work of its network of scholars, which includes scholars from IU and around the world. At IU, the program draws on faculty from Anthropology, Economics, Geography, Law, Political Science, the School of International and Global Studies, and the School of Public and Environmental Affairs. The study of natural resources has a long tradition at the Ostrom Workshop, and the program will continue to build on that tradition.

#### **Program Components**

- Ostrom Workshop Colloquium Series: natural resource scholars will be a regular and integral component of the series.
- Ostrom Symposium on Natural Resource Governance: invited event to be held annually in the fall and comprised of 6–8 original papers presented for discussion.
- Ostrom Lecture on Environmental Policy: given annually in the spring semester by a distinguished scholar-in-residence (see p. 3 for details regarding February 22, 2017 lecture).
- Outreach and Collaboration: ongoing project with innovative organizations including The Natural Resources Law Working Group at the University of Oslo and the Classical Liberal Institute at NYU School of Law.
- Visiting Scholars: the program will host visiting scholars working on natural resource topics.

# Governance of Internet and Cybersecurity

Officially launched this month, the Program on Governance of Internet and Cybersecurity will be led by Professor Scott Shackelford (associate professor of Business Law and Ethics, IU Kelley School of Business).

The program brings together scholars from across IU and beyond to build scholarly networks, as well as seek out partnerships with managers and policymakers in the United States and abroad in order to translate research findings into effective policy. A polycentric approach to both Internet governance and cybersecurity risk management will be encouraged in this program with scholars coming from diverse backgrounds including, but not limited to: Secure Computing, Law, Business, Economics, Ethics, Public Policy, Media, Education, Psychological and Brain Sciences, Political Science, and International Relations. Only through such a multidisciplinary, multisector, multistakeholder partnership might meaningful progress be made toward engendering sustainable models of Internet governance and an equitable cyber peace.

#### Program Components

- Ostrom Workshop Colloquium Series: cybersecurity and Internet governance scholars will be integrated into the series.
- Cybersecurity Speaker Series: beginning with IU Vice President Brad Wheeler and Dr. Jackie Kerr of Lawrence Livermore National Laboratory, regular cross-listed talks from leading voices will be held in collaboration with the Center for Applied Cybersecurity Research and the Kelley School of Business, along with other interested partners.
- Ostrom Workshop Colloquium on Cybersecurity and Internet Governance, April 27–29, 2017 (see p. 3 for details).
- Outreach and Collaboration: state governments, including the Indiana Office of Technology, as well as leading private firms, civil society, academic centers such as the Internet Corporation for Assigned Names and Numbers (ICANN), the United Nations' International Telecommunication Union, among other public- and private-sector stakeholders.
- Visiting Scholars: the program will host visiting scholars working on cybersecurity and Internet governance topics.

## Ostrom Symposium in Beijing

As part of Indiana University's Bicentennial celebration, leading scholars and practitioners from across China and IU discussed the lasting legacy and impact of work by Elinor and Vincent Ostrom's research in China at the "Ostrom Symposium on the Study of the Commons, Governance, and Collective Decision."

On December 7, 2016, IU President Michael McRobbie gave opening remarks at the all-day symposium at the IU China Gateway office in Beijing. As President McRobbie explained in his welcoming remarks, Lin had a "profound impact" on development studies around the world, and she was largely responsible for the development of the study of the commons, a field that has exploded over the past quarter century.

Many of those in attendance at the symposium were members of the Chinese Ostrom Society, founded in 2009 to study and explore the Ostroms' ideas and methods on resource management and polycentric governance. The society features several scholars who have worked to translate the Ostroms' many writings into Chinese, including Wang Jianxun, an IU alumnus now on the faculty of the China University of Political Science and Law, and Professor Mao Shoulong of Renmin University, whose team of writers has translated almost all of the Ostroms' core works and facilitated their publication in China.


- ROY GARDNER MEMORIAL LECTURE, given by Professor Ehud Kalai, Northwestern University; IU Bloomington, September 1, 2016.
- OSTROM SYMPOSIUM ON NATURAL RESOURCE GOVERNANCE, IU Bloomington, October 7–8, 2016. Convener: Dean Lueck. This new invited event is part of our Program on Governance of Natural Resources and will be held annually in the fall. Sixteen scholars from IU and other institutions (including the University of Pennsylvania and Stanford University) presented and discussed topics on land use regulations, the performance of environmental agencies, water rights, and energy policy. Robert Bish, former student of Vincent Ostrom and emeritus professor of economics at the University of Victoria, Canada, led a discussion on the history of the Workshop and the legacy of the Ostroms.
- SPECIAL ROUNDTABLE, "Is There a Role for Moderation in America's Polarized Politics?," IUB, October 21, 2016 (see *IU Policy Briefings*; see also archived live stream). *Panelists*: Lee H. Hamilton (former congressman, School of Global & International Studies, SPEA), Geoffrey Kabaservice (author of *Rule and Ruin*), and Leslie Lenkowsky (SPEA). *Moderator*: Edward Carmines (Political Science).
- INFORMALITY AND DEVELOPMENT: A CONFERENCE IN HONOR OF ELINOR OSTROM, IU Bloomington, October 22–23, 2016. Conveners: Michael Alexeev (professor of economics, IU) and Ravi Kanbur (T. H. Lee Professor of World Affairs, Cornell University). The Ostrom Workshop and Cornell University organized a conference to honor the memory and the legacy of Elinor Ostrom by exploring the intersection between informality and development. The conference organizers were Michael Alexeev and Ravi Kanbur (coeditor with Lin of the OUP volume Linking the Formal and Informal Economy, whose 10th anniversary of publication was also marked in 2016).

Conference participation was structured to bring together invited senior scholars with relatively junior researchers who were selected from submissions to a global call for papers. Among the senior participants were Santiago Levy, Vice President of the Inter-American Development Bank, who spoke about informality and productivity in Mexico; Nancy Benjamin of the World Bank, who presented on informality in West Africa; Martha Chen of Harvard University, who presented a framework for assessing the urban commons and their impact on urban livelihoods; and Hartmut Lehmann of the University of Bologna, who focused on informality in countries under transition from Soviet-type socialism. This broad global spread of coverage was also seen in the presentations of the junior scholars. Overall, the 14 papers presented at the conference covered informality in a broad range of countries including Afghanistan, Benin, Burkina Faso, Democratic Republic of Congo, Ghana, India, Peru, Russia, Senegal, Tajikistan, Tanzania, Uganda, Ukraine, Vietnam, and Zambia.




Italia Civile: Associazionismo, Partecipazione e Politica




## Faces of Moderation: The Art of Balance in an Age of Extremes





#### Elinor Ostrom: An Intellectual Biography

#### VLAD TARKO ROWMAN & LITTLEFIELD, 2016

Elinor Ostrom was the first woman to win the Nobel Prize in Economic Sciences. She has been at the forefront of New Institutional Economics and Public Choice revolutions, discovering surprising ways in which communities around the world have succeeded in solving difficult collective problems. She first rose

to prominence by studying the police in metropolitan areas in the United States, and showing that, contrary to the prevailing view at the time, community policing and smaller departments worked better than centralized and large police departments. Together with her husband, Vincent, they set up the Bloomington Workshop in Political Theory and Policy Analysis, which has grown into a global network of scholars and practitioners.

'he Responsive Forest Governance Initiative (RFGI) is a research program focused on environmental governance in Africa. RFGI is jointly managed by the Council for the Development of Social Science Research in Africa (CODESRIA), the International Union for the Conservation of Nature (IUCN), and the Social Dimensions of Environmental Policy (SDEP) Program of the University of Illinois at Urbana Champaign. RFGI was generously supported by the Swedish International Development Agency (Sida). RFGI has focused on local representation in climate adaptation and mitigation in the forestry sector in Burkina Faso, Cameroon, the Democratic Republic of Congo, Ghana, Kenya, Mozambique, Nigeria, Senegal, South Sudan, Tanzania, and Uganda, with comparative cases in Nepal and Peru. The 35 working papers that have come from the RFGI research program from 2011 to 2015 are now all available online.

The main topics of the publications include: learning from projects to improve conservation interventions; sharing the benefits of forest resources; improving representation of local people; and carbon forestry, including REDD+.

#### **OUR LEGACY**

The Workshop in Political Theory and Policy Analysis was founded at Indiana University in 1973 by Nobel Prize—winning economist Elinor Ostrom and her husband, Vincent. Over its 40-year history, Ostrom Workshop scholars have produced pioneering research and taught generations of students about the ways in which governance processes at the local, national, and global level can be crafted to enhance human well-being, while promoting democratic principles and sustainable resource management.

#### WHAT WE DO

Today, the Ostrom Workshop continues to address issues of governance. By governance, we mean the formal and informal rules that shape human behavior. Governance failures prevent us from getting the most out of available human, physical, and financial resources. Only by understanding the nature and causes of governance failures will we be able to solve complex societal problems. To do so, we take an interdisciplinary approach that aims at leveraging the knowledge produced both within and across a number of research areas.

#### **OUR FUTURE**

The Ostrom Workshop is expanding to support innovative work in a variety of research areas, including natural resources; economic, legal, and political development; Internet and cybersecurity; and governance of data. Future research areas may include financial organizations, international organizations, public health, and education.
